Officers' Reports

Chair's Comments:

1. Steve welcomed the board members to the meeting.

Executive Director's Comments:

- 1. CanAm update.
 - a. Neil reported that he has had contact with the fairgrounds, and AKC/ESPN regarding the 2021 CanAm competition.
 - b. The poll regarding expected attendance at CanAm is not closed yet with approximately 65% of respondents indicating they plan to, or may plan to attend.
 - c. Accommodations may be made, such as adjusting the date on which seed times are due to help competitors.
- 2. Neil has received feedback from judges relating to the absence of line and box judges. Judges feel a lot of pressure to do well. The benefit of having no line judge seems minimal and asking competitors to allow them space could work well to bring them back into the ring. Opinions regarding the absence of box judges was mixed. Neil suggests the rules committee should consider making box judges optional.
- 3. In region 3, the new Laser Measuring Apparatus was well received. No judges were certified to use the apparatus so no official measurements were taken. Some dogs were very nervous about the table as they associated it with grooming.
